

Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.57%) gained 35.45 points and closed at 6,250.50. The bluechip index DS30 (+0.41%), the Shariah-based index DSES (+0.52%), and the large-cap index CDSET (+0.27%) closed at 2,208.10, 1,364.59, and 1,218.74 points, respectively. All the large-cap sectors posted positive performance today. Pharmaceutical booked the highest gain of 0.63% followed by Food & Allied (+0.17%), NBFI (+0.09%), Bank (+0.09%), Fuel Power (+0.07%), Engineering (+0.03%), & and Telecommunication (0.00%), respectively. Block trades contributed 8.9% of the overall market turnover. Genex Infosys Limited (+8.7%) was the most traded share with a turnover of BDT 631 million.
