Market closed in green


The market closed in green today. The benchmark index DSEX (+0.03%) gained 2.37 points and closed at 7.019.60. The bluechip index DS30 (-0.69%), the Shariah-based index DSES (+0.02%), and the large-cap index CDSET (-0.63%) closed at 2,598.35, 1,502.01, and 1,398.24 points, respectively. Largesectors posted mixed performance Telecommunication experienced the highest loss of 1.18% followed by Bank (-0.24%), Pharmaceutical (-0.20%), Fuel & Power (-0.10%), NBFI (-0.01%), Food & Allied (+0.21%), and Engineering (+0.45%), respectively. Block trades contributed 0.7% of the overall market turnover. Bangladesh Export Import Company Ltd. (-2.7%) was the most traded share with a turnover of BDT 872 million.


