Market closed in green


The market closed in green today. The benchmark index DSEX (+0.51%) gained 35.67 points and closed at 7,055.27. The bluechip index DS30 (+0.37%), the Shariah-based index DSES (+0.20%), and the large-cap index CDSET (+0.31%) closed at 2,607.83, 1,505.01, and 1,402.63 points, respectively. Largesectors posted mixed performance Telecommunication booked the highest gain of 0.80% followed by Pharmaceutical (+0.39%), Bank (+0.38%), Engineering (+0.10%). Fuel & Power experienced the highest loss of 0.73% followed by NBFI (-0.31%), Food & Allied (-0.25%). Block trades contributed 0.5% of the overall market turnover. Bangladesh Shipping Corporation (+9.8%) was the most traded share with a turnover of BDT 1,315 million.


