# Market closed in green

The market closed in green today. The benchmark index DSEX (+0.48%) gained 33.72 points and closed at 7,089.43. The blue-chip index DS30 (+0.71%), the Shariah-based index DSES (+0.17%), and the large-cap index CDSET (+0.78%) closed at 2,617.31, 1,509.15, and 1,409.01 points, respectively. Large-cap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.71% followed by Fuel & Power (+0.25%), Food & Allied (+0.09%), Bank (+0.02%). Telecommunication experienced the highest loss of 0.3% followed by Engineering (-0.17%), NBFI (-0.15%). Block trades contributed 0.7% of the overall market turnover. Bangladesh Export Import Company Ltd. (+5.3%) was the most traded share with a turnover of BDT 1,774 million.




