The market closed in green today. The benchmark index DSEX (+0.23%) gained 16.26 points and closed at 7,105.69. The blue-chip index DS30 (+0.69%), the Shariah-based index DSES (-0.05%), and the large-cap index CDSET (+0.71%) closed at 2,635.38, 1,508.40, and 1,419.08 points, respectively. Most of the large-cap sectors posted negative performance today. Engineering experienced the highest loss of 2.21% followed by NBFI (-0.61%), Telecommunication (-0.42%), Fuel & Power (-0.27%), Bank (-0.10%), Food & Allied (+0.08%), and Pharmaceutical (+0.68%), respectively. Block trades contributed 0.4% of the overall market turnover. Bangladesh Export Import Company Ltd. (+5.7%) was the most traded share with a turnover of BDT 2,465 million.


