Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.12%) gained 7.58 points and closed at 6,263.51. The bluechip index DS30 (+0.33%), the Shariah-based index DSES (+0.33%), and the large-cap index CDSET (+0.30%) closed at 2,211.72, 1,365.17, and 1,219.52 points, respectively. Largecap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.57% followed by NBFI (+0.11%), Food & Allied (+0.06%), Engineering (+0.04%). Fuel & Power experienced the highest loss of 0.07% followed by Bank (-0.03%), Telecommunication (0.00%). Block trades contributed 11.4% of the overall market turnover. Genex Infosys Limited (-5.0%) was the most traded share with a turnover of BDT 457 million.




