


The market closed in red today. The benchmark index DSEX (0.00%) lost 0.13 points and closed at 7,032.44. The blue-chip index DS30 (-0.04%), the Shariah-based index DSES (-0.04%), and the large-cap index CDSET (-0.04%) closed at 2,612.16, 1,504.05, and 1,406.89 points, respectively. Large-cap sectors posted mixed performance today. NBFI booked the highest gain of 2.15% followed by Bank (+0.12%), Pharmaceutical (+0.09%), Telecommunication (+0.03%). Food & Allied experienced the highest loss of 0.35% followed by Fuel & Power (-0.20%), Engineering (-0.14%). Block trades contributed 0.6% of the overall market turnover. Bangladesh Export Import Company Ltd. (-0.1%) was the most traded share with a turnover of BDT 831 million.


