The market closed in red today. The benchmark index DSEX (-0.93%) lost 65.26 points and closed at 6,926.29. The blue-chip index DS30 (-1.01%), the Shariah-based index DSES (-0.62%), and the large-cap index CDSET (-0.99%) closed at 2,559.15, 1,481.89, and 1,381.68 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 1.91% followed by Pharmaceutical (-0.59%), Bank (-0.57%), Fuel & Power (-0.57%), Engineering (-0.52%), Food & Allied (-0.44%), and Telecommunication (-0.07%), respectively. Block trades contributed 0.5% of the overall market turnover. Union Bank Limited (-0.8%) was the most traded share with a turnover of BDT 903 million.


