Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.19%) lost 11.79 points and closed at 6,267.05. The blue-chip index DS30 (-0.28%), the Shariah-based index DSES (-0.31%), and the large-cap index CDSET (-0.10%) closed at 2,219.60, 1,366.01, and 1,221.56 points, respectively. Largecap sectors posted mixed performance today. Food & Allied booked the highest gain of 0.16% followed by Fuel & Power (+0.10%), Telecommunication (0.00%). Pharmaceutical experienced the highest loss of 0.31% followed by Engineering (-0.03%), Bank (0.00%), NBFI (0.00%). Block trades contributed 21.9% of the overall market turnover. Genex Infosys Limited (-3.0%) was the most traded share with a turnover of BDT 579 million.




