Daily Market Update

The market closed in green today. The benchmark index DSEX (+2.30%) gained 123.72 points and closed at 5,497.56. The blue-chip index DS30 (+2.01%), the Shariah-based index DSES (+1.87%), and the large-cap index CDSET (+1.83%) closed at 1,951.34, 1,208.70, and 1,056.17 points, respectively. All the large-cap sectors posted positive performance today. NBFI booked the highest gain of 4.55% followed by Telecommunication (+2.92%), Bank (+2.87%), Food & Allied (+2.51%), Fuel & Power (+2.24%), Pharmaceutical (+1.63%), and Engineering (+1.59%), respectively. Block trades contributed 9.4% of the overall market turnover. Orion Pharma Ltd. (+3.5%) was the most traded share with a turnover of BDT 275 million.




