


Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.10%) lost 6.26 points and closed at 6,361.16. The blue-chip index DS30 (-0.11%), the Shariah-based index DSES (-0.04%), and the large-cap index CDSET (+0.04%) closed at 2,200.36, 1,386.77, and 1,215.03 points, respectively. Largecap sectors posted mixed performance today. Bank booked the highest gain of 0.29% followed by NBFI (+0.14%), Pharmaceutical (+0.06%). Fuel & Power experienced the highest loss of 0.09% followed by Engineering (-0.08%), Food & Allied (-0.04%). Block trades contributed 7.9% of the overall market turnover. Fu Wang Food Ltd. (-8.0%) was the most traded share with a turnover of BDT 817 million.




