# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.67%) lost 36.64 points and closed at 5,446.50. The blue-chip index DS30 (-0.41%), the Shariah-based index DSES (-0.87%), and the large-cap index CDSET (-0.50%) closed at 1,953.27, 1,191.43, and 1,046.21 points, respectively. Most of the large-cap sectors posted negative performance today. Engineering experienced the highest loss of 2.36% followed by NBFI (-2.05%), Fuel & Power (-1.39%), Food & Allied (-0.58%), Pharmaceutical (-0.58%), Telecommunication (-0.12%), and Bank (+0.57%), respectively. Block trades contributed 8.6% of the overall market turnover. Sea Pearl Beach Resort & Spa Limited (-2.9%) was the most traded share with a turnover of BDT 159 million.




