The market closed in red today. The benchmark index DSEX (-1.21%) lost 74.24 points and closed at 6,038.00. The blue-chip index DS30 (-1.24%), the Shariah-based index DSES (-1.06%), and the large-cap index CDSET (-1.14%) closed at 2,162.85, 1,319.84, and 1,199.38 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 1.67% followed by Engineering (-1.26%), Food & Allied (-1.20%), Fuel & Power (-1.08%), Bank (-1.02%), Pharmaceutical (-0.85%), and Telecommunication (-0.55%), respectively. Block trades contributed 1.0% of the overall market turnover. KDS Accessories Limited (-0.6%) was the most traded share with a turnover of BDT 301 million.




