


Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.17%) gained 10.58 points and closed at 6,366.14. The blue-chip index DS30 (-0.10%), the Shariah-based index DSES (+0.25%), and the large-cap index CDSET (0.00%) closed at 2,199.05, 1,383.00, and 1,214.38 points, respectively. Large-cap sectors posted mixed performance today. Engineering booked the highest gain of 0.35% followed by Fuel & Power (+0.21%), Pharmaceutical (+0.02%). Food & Allied experienced the highest loss of 0.11% followed by NBFI (-0.08%), Bank (-0.06%). Block trades contributed 15.6% of the overall market turnover. Intraco Refueling Station Limited (+8.9%) was the most traded share with a turnover of BDT 593 million.


