
Market closed in green

The market closed in green today. The benchmark index DSEX (+0.71%) gained 45.86 points and closed at 6,497.39. The bluechip index DS30 (+0.77%), the Shariah-based index DSES (+0.73%), and the large-cap index CDSET (+0.88%) closed at 2,373.80, 1,426.08, and 1,296.72 points, respectively. Most of the large-cap sectors posted positive performance today. Food & Allied booked the highest gain of 2.19% followed by Telecommunication (+2.13%), Fuel & Power (+1.05%), Engineering (+0.79%), Pharmaceutical (+0.62%), Bank (+0.17%), and NBFI (-0.12%), respectively.Block trades contributed 0.6% of the overall market turnover. Bangladesh Export Import Company Ltd. (+0.1%) was the most traded share with a turnover of BDT 387 million.




