Market closed in green


The market closed in green today. The benchmark index DSEX (+0.24%) gained 15.64 points and closed at 6,484.25. The blue-chip index DS30 (+0.12%), the Shariah-based index DSES (+0.15%), and the large-cap index CDSET (+0.17%) closed at 2,353.65, 1,412.95, and 1,289.29 points, respectively. Most of the large-cap sectors posted positive performance today. Engineering booked the highest gain of 0.43% followed by Bank (+0.42%), NBFI (+0.22%), Food & Allied (+0.15%), Pharmaceutical (+0.05%), Fuel & Power (-0.01%), and Telecommunication (-0.39%), respectively.Block trades contributed 0.8% of the overall market turnover. Bangladesh Export Import Company Ltd. (0.0%) was the most traded share with a turnover of BDT 561 million.


