


Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.22%) gained 13.85 points and closed at 6,352.84. The blue-chip index DS30 (+0.17%), the Shariah-based index DSES (+0.23%), and the large-cap index CDSET (+0.10%) closed at 2,192.89, 1,378.43, and 1,212.94 points, respectively. All the large-cap sectors posted positive performance today. Food & Allied booked the highest gain of 0.35% followed by Pharmaceutical (+0.32%), Engineering (+0.08%), Fuel & Power (+0.07%), NBFI (+0.04%), Bank (+0.01%), and Telecommunication (0.00%), respectively. Block trades contributed 7.0% of the overall market turnover. Meghna Life Insurance Co. Ltd. (+2.1%) was the most traded share with a turnover of BDT 440 million.


