Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.49%) lost 30.98 points and closed at 6,310.60. The blue-chip index DS30 (-0.26%), the Shariah-based index DSES (-0.41%), and the large-cap index CDSET (-0.07%) closed at 2,185.40, 1,372.07, and 1,210.78 points, respectively. All the large-cap sectors posted negative performance today. Pharmaceutical experienced the highest loss of 0.24% followed by Fuel & Power (-0.22%), Food & Allied (-0.15%), Engineering (-0.14%), NBFI (-0.07%), Bank (-0.06%), and Telecommunication (0.00%), respectively. Block trades contributed 6.7% of the overall market turnover. Meghna Life Insurance Co. Ltd. (-9.5%) was the most traded share with a turnover of BDT 503 million.




