Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.19%) lost 11.68 points and closed at 6,298.92. The blue-chip index DS30 (+0.00%), the Shariah-based index DSES (-0.21%), and the large-cap index CDSET (-0.16%) closed at 2,185.50, 1,369.20, and 1,208.90 points, respectively. Largecap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.15% followed by Engineering (+0.01%), Telecommunication (0.00%). Bank experienced the highest loss of 0.28% followed by Food & Allied (-0.08%), Fuel & Power (-0.05%), NBFI (-0.04%). Block trades contributed 5.8% of the overall market turnover. Navana Pharmaceuticals Limited (+9.1%) was the most traded share with a turnover of BDT 422 million.




