Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.38%) lost 24.16 points and closed at 6,274.76. The blue-chip index DS30 (-0.20%), the Shariah-based index DSES (-0.37%), and the large-cap index CDSET (-0.06%) closed at 2,181.08, 1,364.14, and 1,208.12 points, respectively. All the large-cap sectors posted negative performance today. Food & Allied experienced the highest loss of 0.18% followed by Fuel & Power (-0.15%), Pharmaceutical (-0.07%), NBFI (-0.04%), Bank (-0.04%), Engineering (-0.02%), and Telecommunication (0.00%), respectively. Block trades contributed 8.0% of the overall market turnover. Navana Pharmaceuticals Limited (+0.4%) was the most traded share with a turnover of BDT 449 million.




