Market closed in green

The market closed in green today. The benchmark index DSEX (+0.21%) gained 13.12 points and closed at 6,374.51. The blue-chip index DS30 (+0.04%), the Shariah-based index DSES (+0.14%), and the large-cap index CDSET (+0.02%) closed at 2,301.92, 1,389.60, and 1,262.00 points, respectively. Large-cap sectors posted mixed performance today. NBFI booked the highest gain of 0.50% followed by Engineering (+0.14%), Fuel & Power (+0.11%). Food & Allied experienced the highest loss of 0.85% followed by Pharmaceutical (-0.24%), Bank (-0.13%), Telecommunication (-0.12%).Block trades contributed 1.0% of the overall market turnover. Bangladesh Export Import Company Ltd. (+3.1%) was the most traded share with a turnover of BDT 651 million.




