Market closed in green The market closed in green today. The benchmark index

DSEX (+0.08%) gained 5.26 points and closed at 6,280.02. The blue-chip index DS30 (+0.07%), the Shariah-based index DSES (+0.08%), and the large-cap index CDSET (+0.05%) closed at 2,182.50, 1,365.17, and 1,208.75 points, respectively. Large-cap sectors posted mixed performance today. Food & Allied booked the highest gain of 0.18% followed by Bank (+0.04%), NBFI (+0.01%). Fuel & Power experienced the highest loss of 0.06% followed by Pharmaceutical (-0.05%), Engineering (-0.03%). Block trades contributed 9.7% of the overall market turnover. Bangladesh Shipping Corporation (+2.5%) was the most traded share with a turnover of BDT 236 million.




