

Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.13%) gained 8.29 points and closed at 6,319.25. The blue-chip index DS30 (+0.08%), the Shariah-based index DSES (+0.16%), and the large-cap index CDSET (+0.10%) closed at 2,187.74, 1,372.73, and 1,211.16 points, respectively. Most of the large-cap sectors posted positive performance today. Bank booked the highest gain of 0.19% followed by NBFI (+0.16%), Pharmaceutical (+0.12%), Engineering (+0.07%), Fuel & Power (+0.02%), Telecommunication (0.00%), and Food & Allied (0.00%), respectively. Block trades contributed 25.2% of the overall market turnover. Gemini Sea Food Ltd. (-1.4%) was the most traded share with a turnover of BDT 229 million.




