


The market closed in green today. The benchmark index DSEX (+0.16%) gained 9.85 points and closed at 6,327.65. The bluechip index DS30 (+0.20%), the Shariah-based index DSES (+0.11%), and the large-cap index CDSET (+0.20%) closed at 2,298.60, 1,382.93, and 1,261.66 points, respectively. Most of the large-cap sectors posted positive performance today. Fuel & Power booked the highest gain of 0.88% followed by Bank (+0.30%), Pharmaceutical (+0.07%), Telecommunication (+0.02%), NBFI (+0.02%), Food & Allied (+0.01%), and Engineering (-0.05%), respectively. Block trades contributed 0.8% of the overall market turnover. Bangladesh Export Import Company Ltd. (-0.1%) was the most traded share with a turnover of BDT 394 million.



The Company has informed that the Board of Directors has decided to issue a Zero Coupon Bond amounting BDT 290.00 crore to finance expansion and to reduce debts related to the expansion of the Company subject to approval of the Bangladesh Securities & Exchange Commission.

The Company has informed that the Board of Directors has decided to purchase of 55.00 Bigha i.e. 1,815.00 decimal land at a consideration of approximately Tk.55.00 crore for new plant at Bhaluka, Mymensingh from its Directors/Related parties on fair market price basis, which may exceed I% (one percent) or above of the total tangible assets shown in the statement of financial position as of end of the immediate preceding financial year.

The Company has informed that the Board of Directors has approved the proposal of J.M. Fabrics Ltd., a subsidiary Company of the Company to purchase land measuring an area of 954.94 decimals situated at Mouza: Dogri and Bahadurpur, Upazila: Gazipur Sadar, District: Gazipur at a total consideration of approximately Tk. 47.70 crore only including registration cost for the future expansion of the business of J.M. Fabrics Ltd. The investment of Tk. 47.70 crore would be met from internal generation of funds by JMFL. The Company also informed that they will not be required to provide any funds in this regard.
