# **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.10%) gained 6.46 points and closed at 6,325.71. The blue-chip index DS30 (+0.10%), the Shariah-based index DSES (+0.14%), and the large-cap index CDSET (+0.11%) closed at 2,189.95, 1,374.65, and 1,212.45 points, respectively. Most of the large-cap sectors posted positive performance today. Food & Allied booked the highest gain of 0.22% followed by Pharmaceutical (+0.09%), NBFI (+0.08%), Bank (+0.07%), Fuel & Power (+0.03%), Telecommunication (0.00%), and Engineering (-0.04%), respectively. Block trades contributed 25.8% of the overall market turnover. Navana Pharmaceuticals Limited (+4.6%) was the most traded share with a turnover of BDT 416 million.




