

The market closed in red today. The benchmark index DSEX (-0.42%) lost 26.56 points and closed at 6,301.09. The blue-chip index DS30 (-0.52%), the Shariah-based index DSES (-0.29%), and the large-cap index CDSET (-0.41%) closed at 2,286.60, 1,378.87, and 1,256.54 points, respectively. Large-cap sectors posted mixed performance today. Telecommunication booked the highest gain of 0.29% followed by Food & Allied (+0.24%), Engineering (+0.18%). Fuel & Power experienced the highest loss of 0.57% followed by NBFI (-0.34%), Pharmaceutical (-0.29%), Bank (-0.25%).Block trades contributed 1.3% of the overall market turnover. Fu Wang Food Ltd. (+9.0%) was the most traded share with a turnover of BDT 342 million.




