


Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.42%) gained 26.48 points and closed at 6,376.94. The bluechip index DS30 (+0.02%), the Shariah-based index DSES (+0.10%), and the large-cap index CDSET (+0.14%) closed at 2,295.59, 1,386.78, and 1,263.08 points, respectively. All the large-cap sectors posted positive performance today. NBFI booked the highest gain of 1.72% followed by Bank (+1.33%), Fuel & Power (+0.38%), Food & Allied (+0.27%), Engineering (+0.19%), Telecommunication (+0.04%), and Pharmaceutical (-0.20%), respectively.Block trades contributed 1.3% of the overall market turnover. Anwar Galvanizing Ltd. (+2.7%) was the most traded share with a turnover of BDT 401 million.




