Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.10%) lost 6.06 points and closed at 5,968.04. The blue-chip index DS30 (-0.24%), the Shariah-based index DSES (-0.08%), and the large-cap index CDSET (-0.19%) closed at 2,051.58, 1,299.80, and 1,125.40 points, respectively. Large-cap sectors posted mixed performance today. Telecommunication booked the highest gain of 0.57%, followed by Fuel & Power (+0.38%), Engineering (+0.35%), Pharmaceutical (-0.15%), Bank (-0.27%), Food & Allied (-0.54%), and NBFI (-0.70%), respectively. Block trades contributed 6.1% of the overall market turnover. Golden Son Ltd. (+1.8%) was the most traded share with a turnover of BDT 279 million.






Figure: Sectorial Turnover (BDT Mn)
