Daily Market Update

The market closed in green today. The benchmark index DSEX (+1.18%) gained 69.08 points and closed at 5,941.66. The blue-chip index DS30 (+1.25%), the Shariah-based index DSES (+1.21%), and the large-cap index CDSET (+0.80%) closed at 2,057.72, 1,293.03, and 1,118.10 points, respectively. Most of the large-cap sectors posted positive performance today. Telecommunication booked the highest gain of 2.32% followed by NBFI (+1.89%), Pharmaceutical (+1.19%), Fuel & Power (+0.88%), Food & Allied (+0.85%), Engineering (+0.76%), and Bank (+0.66%), respectively. Block trades contributed 5.0% of the overall market turnover. Best Holdings Limited (+5.0%) was the most traded share with a turnover of BDT 299 million.




