Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.87%) lost 53.38 points and closed at 6,112.76. The blue-chip index DS30 (-0.57%), the Shariah-based index DSES (-0.53%), and the large-cap index CDSET (-0.53%) closed at 2,094.34, 1,335.89, and 1,151.34 points, respectively. All the large-cap sectors posted negative performance today. Food & Allied experienced the highest loss of 2.62% followed by NBFI (-1.91%), Fuel & Power (-0.92%), Telecommunication (-0.88%), Engineering (-0.74%), Bank (-0.53%), and Pharmaceutical (-0.28%), respectively. Block trades contributed 9.1% of the overall market turnover. Fu-Wang Ceramic Industries Ltd. (+1.0%) was the most traded share with a turnover of BDT 409 million.




