Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.04%) lost 2.26 points and closed at 6,214.69. The blue-chip index DS30 (-0.12%), the Shariah-based index DSES (-0.14%), and the large-cap index CDSET (-0.07%) closed at 2,218.35, 1,357.75, and 1,219.91 points, respectively. Largecap sectors posted mixed performance today. Food & Allied booked the highest gain of 0.07% followed by NBFI (+0.03%), Engineering (+0.02%), Bank (+0.01%). Pharmaceutical experienced the highest loss of 0.22% followed by Fuel & Power (0.00%), Telecommunication (0.00%). Block trades contributed 13.3% of the overall market turnover. Genex Infosys Limited (-0.4%) was the most traded share with a turnover of BDT 241 million.




