


The market closed in red today. The benchmark index DSEX (-0.80%) lost 53.95 points and closed at 6,699.84. The blue-chip index DS30 (-0.78%), the Shariah-based index DSES (-0.71%), and the large-cap index CDSET (-0.65%) closed at 2,470.51, 1,443.42, and 1,341.81 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 1.42% followed by Telecommunication (-1.34%), Engineering (-1.30%), Fuel & Power (-0.88%), Bank (-0.87%), Food & Allied (-0.61%), and Pharmaceutical (-0.45%), respectively. Block trades contributed 0.6% of the overall market turnover. Bangladesh Export Import Company Ltd. (0.0%) was the most traded share with a turnover of BDT 1,103 million.


