


Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.05%) gained 2.84 points and closed at 6,262.31. The blue-chip index DS30 (0.00%), the Shariah-based index DSES (-0.02%), and the large-cap index CDSET (-0.05%) closed at 2,225.88, 1,361.58, and 1,217.04 points, respectively. Large-cap sectors posted mixed performance today. Fuel & Power booked the highest gain of 0.18% followed by Bank (+0.15%), Telecommunication (0.00%). Engineering experienced the highest loss of 0.08% followed by Pharmaceutical (-0.08%), NBFI (-0.05%), Food & Allied (-0.04%). Block trades contributed 9.3% of the overall market turnover. Eastern Housing Limited (+4.4%) was the most traded share with a turnover of BDT 377 million.




