Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.03%) lost 2.13 points and closed at 6,260.18. The blue-chip index DS30 (+0.05%), the Shariah-based index DSES (+0.05%), and the large-cap index CDSET (0.00%) closed at 2,226.97, 1,362.33, and 1,217.01 points, respectively. Largecap sectors posted mixed performance today. Food & Allied booked the highest gain of 0.08% followed by Pharmaceutical (+0.03%), Telecommunication (0.00%). Bank experienced the highest loss of 0.15% followed by Fuel & Power (-0.13%), NBFI (-0.05%), Engineering (-0.03%). Block trades contributed 6.7% of the overall market turnover. Genex Infosys Limited (-0.1%) was the most traded share with a turnover of BDT 413 million.




