
Market closed in green

The market closed in green today. The benchmark index DSEX (+1.46%) gained 97.59 points and closed at 6,765.73. The blue-chip index DS30 (+1.57%), the Shariah-based index DSES (+1.24%), and the large-cap index CDSET (+1.41%) closed at 2,463.19, 1,453.18, and 1,337.45 points, respectively. All the large-cap sectors posted positive performance today. NBFI booked the highest gain of 2.29% followed by Telecommunication (+1.80%), Food & Allied (+1.54%), Fuel & Power (+1.25%), Pharmaceutical (+1.06%), Engineering (+0.82%), and Bank (+0.76%), respectively. Block trades contributed 0.6% of the overall market turnover. Bangladesh Export Import Company Ltd. (+1.6%) was the most traded share with a turnover of BDT 726 million.


