Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.14%) gained 8.59 points and closed at 6,243.57. The blue-chip index DS30 (+0.09%), the Shariah-based index DSES (+0.07%), and the large-cap index CDSET (-0.01%) closed at 2,223.49, 1,359.86, and 1,217.20 points, respectively. Most of the large-cap sectors posted negative performance today. Food & Allied experienced the highest loss of 0.34% followed by Bank (-0.07%), Fuel & Power (-0.05%), Pharmaceutical (-0.02%), Engineering (0.00%), Telecommunication (0.00%), and NBFI (+0.08%), respectively. Block trades contributed 12.7% of the overall market turnover. Rupali Life Insurance Company Limited (+9.8%) was the most traded share with a turnover of BDT 277 million.




