# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.19%) lost 11.62 points and closed at 6,231.96. The blue-chip index DS30 (-0.26%), the Shariah-based index DSES (-0.35%), and the large-cap index CDSET (-0.22%) closed at 2,217.68, 1,355.16, and 1,214.49 points, respectively. Most of the large-cap sectors posted negative performance today. Pharmaceutical experienced the highest loss of 0.43% followed by Fuel & Power (-0.06%), Food & Allied (-0.06%), Bank (-0.03%), Engineering (-0.01%), Telecommunication (0.00%), and NBFI (+0.06%), respectively. Block trades contributed 25.1% of the overall market turnover. Rupali Life Insurance Company Limited (+6.8%) was the most traded share with a turnover of BDT 364 million.




