


The market closed in red today. The benchmark index DSEX (-0.31%) lost 21.26 points and closed at 6,750.40. The blue-chip index DS30 (-0.07%), the Shariah-based index DSES (-0.28%), and the large-cap index CDSET (-0.14%) closed at 2,469.44, 1,456.43, and 1,341.08 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 1.86% followed by Bank (-0.44%), Engineering (-0.42%), Pharmaceutical (-0.32%), Fuel & Power (-0.30%), Food & Allied (-0.14%), and Telecommunication (-0.12%), respectively. Block trades contributed 0.8% of the overall market turnover. Bangladesh Export Import Company Ltd. (-0.7%) was the most traded share with a turnover of BDT 1,249 million.


