Market closed in red The market closed in red today. The benchmark index DSEX (-

0.17%) lost 10.84 points and closed at 6,193.08. The blue-chip index DS30 (-0.21%), the Shariah-based index DSES (-0.30%), and the large-cap index CDSET (-0.22%) closed at 2,210.71, 1,345.62, and 1,210.73 points, respectively. All the large-cap sectors posted negative performance today. Pharmaceutical experienced the highest loss of 0.26% followed by Bank (-0.18%), Food & Allied (-0.10%), Fuel & Power (-0.04%), Engineering (-0.01%), NBFI (0.00%), and Telecommunication (0.00%), respectively. Block trades contributed 11.3% of the overall market turnover. Eastern Housing Limited (+3.9%) was the most traded share with a turnover of BDT 204 million.




