


# **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.06%) gained 3.67 points and closed at 6,196.75. The blue-chip index DS30 (-0.17%), the Shariah-based index DSES (+0.15%), and the large-cap index CDSET (-0.09%) closed at 2,206.99, 1,347.68, and 1,209.61 points, respectively. Large-cap sectors posted mixed performance today. Food & Allied booked the highest gain of 0.04% DSEX followed by Fuel & Power (+0.04%), Engineering (+0.03%). Bank experienced the highest loss of 0.08% followed by Pharmaceutical (-0.07%), NBFI (0.00%). Block trades contributed 9.8% of the overall market turnover. Eastern Housing Limited (-0.4%) was the most traded share with a turnover of BDT 268 million.




