


## Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.16%) gained 10.05 points and closed at 6,206.80. The blue-chip index DS30 (+0.11%), the Shariah-based index DSES (+0.12%), and the large-cap index CDSET (+0.02%) closed at 2,209.44, 1,349.33, and 1,209.83 points, respectively. Large-cap sectors posted mixed performance today. Food & Allied booked the highest gain of 0.26% followed by Pharmaceutical (+0.11%), Bank (+0.06%), Engineering (+0.06%). Fuel & Power experienced the highest loss of 0.01% followed by NBF1 (0.00%), Telecommunication (0.00%). Block trades contributed 27.2% of the overall market turnover. Gemini Sea Food Ltd. (+8.8%) was the most traded share with a turnover of BDT 478 million.

Figure: Sectorial Turnover (BDT Mn)





Figure: Sectorial Mcap Change
