# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.26%) lost 12.94 points and closed at 4,951.73. The blue-chip index DS30 (-0.56%), the Shariah-based index DSES (-0.82%), and the large-cap index CDSET (-0.30%) closed at 1,833.77, 1,089.91, and 1,011.92 points, respectively. Most of the largecap sectors posted negative performance today. Engineering experienced the highest loss of 2.16% followed by Fuel & Power (-1.25%), Food & Allied (-0.83%), NBFI (-0.77%), Pharmaceutical (-0.69%), Telecommunication (-0.59%), and Bank (+2.50%), respectively. Block trades contributed 5.7% of the overall market turnover. Beach Hatchery Ltd. (-6.3%) was the most traded share with a turnover of BDT 552 million.




