Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.12%) lost 7.72 points and closed at 6,261.63. The blue-chip index DS30 (-0.34%), the Shariah-based index DSES (-0.04%), and the large-cap index CDSET (-0.20%) closed at 2,196.37, 1,367.53, and 1,212.88 points, respectively. Most of the large-cap sectors posted negative performance today. Food & Allied experienced the highest loss of 0.28% followed by Bank (-0.12%), Pharmaceutical (-0.06%), NBFI (-0.04%), Fuel & Power (-0.03%), Telecommunication (0.00%), and Engineering (+0.03%), respectively. Block trades contributed 4.5% of the overall market turnover. Paramount Textile Limited (0.0%) was the most traded share with a turnover of BDT 386 million.




