

# **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.09%) gained 5.51 points and closed at 6,279.11. The blue-chip index DS30 (-0.09%), the Shariah-based index DSES (+0.27%), and the large-cap index CDSET (-0.06%) closed at 2,198.41, 1,373.57, and 1,212.47 points, respectively. All the large-cap sectors posted positive performance today. Bank booked the highest gain of 0.58% followed by Food & Allied (+0.37%), Fuel & Power (+0.18%), Engineering (+0.15%), Pharmaceutical (+0.12%), NBFI (+0.04%), and Telecommunication (0.00%), respectively. Block trades contributed 3.8% of the overall market turnover. Intraco Refueling Station Limited (+4.5%) was the most traded share with a turnover of BDT 278 million.




