Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.06%) gained 4.04 points and closed at 6,281.25. The blue-chip index DS30 (0.00%), the Shariah-based index DSES (-0.04%), and the large-cap index CDSET (-0.13%) closed at 2,193.32, 1,368.01, and 1,211.34 points, respectively. Large-cap sectors posted mixed performance today. Engineering booked the highest gain of 0.07% followed by NBFI (+0.03%), Pharmaceutical (+0.02%). Food & Allied experienced the highest loss of 0.6% followed by Fuel & Power (-0.21%), Bank (-0.07%). Block trades contributed 4.3% of the overall market turnover. Bangladesh Shipping Corporation (+0.8%) was the most traded share with a turnover of BDT 367 million.




