# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (0.00%) lost 0.29 points and closed at 6,305.90. The blue-chip index DS30 (-0.03%), the Shariah-based index DSES (-0.10%), and the large-cap index CDSET (-0.04%) closed at 2,195.08, 1,369.83, and 1,211.05 points, respectively. Largecap sectors posted mixed performance today. Fuel & Power booked the highest gain of 0.12% followed by Pharmaceutical (+0.10%), Food & Allied (+0.04%). Bank experienced the highest loss of 0.16% followed by Engineering (-0.08%), NBFI (-0.04%). Block trades contributed 11.9% of the overall market turnover. Navana Pharmaceuticals Limited (+10.0%) was the most traded share with a turnover of BDT 372 million.




