


# **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.31%) gained 19.83 points and closed at 6,325.73. The blue-chip index DS30 (+0.16%), the Shariah-based index DSES (+0.07%), and the large-cap index CDSET (+0.03%) closed at 2,198.50, 1,370.78, and 1,211.38 points, respectively. Most of the large-cap sectors posted positive performance today. Bank booked the highest gain of 0.19% DSEX followed by Fuel & Power (+0.05%), Food & Allied (+0.05%), Pharmaceutical (+0.04%),Engineering (+0.04%)Telecommunication (0.00%), and NBFI (-0.02%), respectively. Block trades contributed 5.7% of the overall market turnover. Bangladesh Shipping Corporation (-0.1%) was the most traded share with a turnover of BDT 464 million.




