


The market closed in green today. The benchmark index DSEX (+0.30%) gained 19.33 points and closed at 6,388.66. The bluechip index DS30 (+0.16%), the Shariah-based index DSES (+0.12%), and the large-cap index CDSET (+0.32%) closed at 2,350.81, 1,401.49, and 1,282.83 points, respectively. Most of the large-cap sectors posted negative performance today. Engineering experienced the highest loss of 0.30% followed by Fuel & Power (-0.25%), NBFI (-0.11%), Food & Allied (-0.11%), Telecommunication (-0.07%), Pharmaceutical (+0.29%), and Bank (+1.74%), respectively. Block trades contributed 0.6% of the overall market turnover. Bangladesh Export Import Company Ltd. (-0.1%) was the most traded share with a turnover of BDT 650 million.


