# **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.56%) gained 35.66 points and closed at 6,388.56. The bluechip index DS30 (+0.37%), the Shariah-based index DSES (+0.68%), and the large-cap index CDSET (+0.35%) closed at 2,244.15, 1,399.19, and 1,231.79 points, respectively. Most of the large-cap sectors posted positive performance today. Pharmaceutical booked the highest gain of 0.57% followed by Fuel & Power (+0.28%), Engineering (+0.10%), Food & Allied (+0.06%), Bank (+0.03%), Telecommunication (0.00%), and NBFI (-0.16%), respectively. Block trades contributed 0.8% of the overall market turnover. Bangladesh Export Import Company Ltd. (+1.0%) was the most traded share with a turnover of BDT 1,989 million.




