### Market closed in green

The market closed in green today. The benchmark index DSEX (+0.20%) gained 9.63 points and closed at 4,928.02. The blue-chip index DS30 (+0.20%), the Shariah-based index DSES (+0.30%), and the large-cap index CDSET (+0.25%) closed at 1,702.37, 1,115.55, and 992.73 points, respectively. Large-cap sectors posted mixed performance today. Bank booked the highest gain of 0.58% followed by Pharmaceutical (+0.48%), Fuel & Power (+0.43%) and Food & Allied (+0.01%). Engineering experienced the highest loss of 2.33% followed by NBFI (-1.85%) and Telecommunication (-0.14%). Block trades contributed 1.4% of the overall market turnover. Beximco Pharmaceuticals Ltd. (+2.1%) was the most traded share with a turnover of BDT 741 million.




